

# Minutes General Assembly 2012

26 September 2012, 17.30 - 19.00 Clarion Hotel and Conference, Trondheim

### 1. Welcome and opening

The General Assembly was opened by the Head of the Board, Inger B. Scheel.

# 5. Activities of the Norwegian Forum for Global Health Research

# a) Report on activities in 2011 and 2012

The head of the board, Inger B. Scheel, briefed the General Assembly on the Forum's activities.

Inger B. Scheel explained the General Assembly about the funding of Norwegian Forum for Global Health Research. Funding has been received from the Research Council of Norway, but it has been difficult to adapt the application for funding to a format with timelines and very specific deliverables as required in the application form.

The GLOBVAC board invited the head of the board and the head of the secretariat of Norwegian Forum for Global Health Research to a meeting to discuss the application process. The GLOBVAC board suggested a change in how Norwegian Forum for Global Health Research can apply for funding. A less rigid format and less rigid reporting combined with an annual meeting with the GLOBVAC board will be important elements of the revised application procedure.

Inger B. Scheel, currently President of Federation of European Societies for Tropical Medicine and International Health (FESTMIH) reported that the Norwegian Forum for Global Health Research is generally more active than European sister societies. The Forum is uniquely positioned to engage in current affairs, thanks to the structure of the Board with observers from policy-making institutions and the Research Council of Norway.

The General Assembly was briefed on the status of the <u>project database</u>. A challenge is to keep the database updated. The board members were encouraged to ensure that projects at their institutions are included in the database.
